Bible translation, literacy, and related mobilization and discipleship activities - Pioneer Bible consists of 425 teammates worldwide ministering to 32 million people in 66 different language projects in 16 countries. During 2016, the number of overseas missionaries increased by 10.1%. We drafted 22,000 verses of Scripture, and processed another 37,000 verses through the exegetical check, 31,000 in comprehension testing, 23,000 in the consultant check, and published 29,000 verses for the first time. In East Africa over 12,000 New Testaments have been distributed and audio versions are being widely distributed in 10 languages while the Jesus film is now being shown in three languages. The entire Bible of a West African language that was completed in 2015 arrived in country this year and is being

4b (Code:) (Expenses \$ 640,734. including grants of \$) (Revenue \$ 24,501.) Recruitment - Recruiting new missionaries is key to the mission of PBT. The organization had 65 new recruits in 2016. PBT held 34 recruitment events at colleges, churches and other conferences around the U.S. Through those events, about 4,000 people became aware of the need for Bible Translation and the role PBT plays within this global need. About 93 of these are serious inquirers.

Training - Training new and current missionaries is an integral part of Pioneer Bible's mission. In 2016, personal and professional coaching was provided to at least 130 individuals preparing for cross-cultural work. A ministry practicum and planning course was offered in both the fall and the spring, and weekly chapel services were conducted

4c (Code:) (Expenses \$ 324,129. including grants of \$) (Revenue \$) Missionary Care - The Care department served the missionaries in numerous ways in 2016. There were dozens of re-entry contacts and pastoral care debriefs with returning missionaries. Over 2,500 written contacts and hundreds of calls were made to encourage and provide spiritual nurture. The Care Department provided leadership for several major events - 2 different Five-Day Prayer and Fasting events, a Resource Workshop on Marriage on the Mission Field, a Parents of Missionaries Seminar, Two Missionary Send-off Celebrations, and a Discovery Week Prayer Team. A Fasting and Prayer emphasis was continued through the year so that at least one person was fasting and praying each day of the year. The 24/7 prayer initiative was able to have at least one person in prayer every hour of every day. Daily prayer times
