4a (Code:) (Expenses \$ 6,551,834. including grants of \$ 276,007.) (Revenue \$ 9,804.) Bible translation, literacy, and related mobilization and discipleship activities. Pioneer Bible teams around the world are ministering to 31 million people in 65 different language projects in 15 countries. During 2015, the number of overseas missionaries increased by 10.5%. We drafted 26,000 verses of Scripture, and processed another 133,000 verses in the exegetical, comprehension, peer, consultant, publication, and revision steps. We dedicated the New Testament in six languages in East Africa, potentially impacting 2.5 million people. Another entire Bible in a West African language was completed, a New Testament and part of the Old Testament were recorded in a language in Europe, we helped dub the Jesus film into two languages in East Africa, we printed 5,000 copies of a Southeast Asia Bible translation and surpassed

4b (Code:) (Expenses \$ 846,333. including grants of \$) (Revenue \$ 46,880.) Recruitment. Recruiting new missionaries is key to the mission of PBT. The organization had 35 new recruits in 2015. PBT held 37 recruitment events at colleges, churches and other conferences around the U.S. Through those events, about 6,000 people became aware of the need for Bible Translation and the role PBT plays within this global need. About 152 of these are serious inquirers.

Training new and current missionaries is an integral part of PBT's mission. In 2015, personal and professional coaching was provided to at least 120 individuals preparing for cross-cultural work. A ministry practicum and planning course was offered in both the fall and the spring, and weekly chapel services were conducted throughout the year.

4c (Code:) (Expenses \$ 240,534. including grants of \$) (Revenue \$ 3,650.) Missionary Care - The Care Department served the missionaries in numerous ways in 2015. There were dozens of re-entry contacts and pastoral care debriefs with returning missionaries. Over 2,500 written contacts and hundreds of calls were made to encourage and provide spiritual nurture. Hundreds of sessions were conducted with missionary teams to assist in re-entry and field challenges. The Care Department provided leadership for several major events - 2 different Five-Day Prayer and Fasting events, a Resource Workshop on Missionary Thriving, a Parents of Missionaries Seminar, Two Missionary Send-off Celebrations, and a Discovery Week Prayer Team. A Fasting and Prayer emphasis was continued through the year so that at least one person was fasting and praying each day of the year. The 24/7 prayer initiative


